



Senior Partner Christopher Kelley Awarded Leadership Excellence - For Profit by LIBN



What Are Your Rights as a Trust Beneficiary?

Trust beneficiaries are entitled to yearly trust report and other information. Trust reports should be mailed out annually to the beneficiaries and should indicate the Trust's income and expenses, including commissions paid. If, upon request, the trustee fails to send out at least one annual report and refuses to do so, the beneficiaries have the right to request a reporting of the trust from the court.
