Victory For Suffolk County Agriculture – Partner Lisa Clare Kombrink's Big Win



Partner Lisa Clare Kombrink received a big win from the Second Department in a case involving what, if anything, can be built on preserved farmland. The Court overturned a State Supreme Court decision by Justice Thomas Whelan that had struck down two County laws which established detailed guidelines for activities on farmland preserved under the County's farmland preservation program. Twomey Latham represented the Suffolk County Legislature and the County Farmland Committee, and fought back the efforts of the Long Island Pine Barrens Society to jeopardize the County program.

Long before the digital age and proliferation of social media platforms like Facebook and Twitter, Marshall McLuhan mused, "publication is a self-invasion of privacy."
